Purpose of a Memorandum of Understanding



What is a Memorandum of Understanding, commonly referred to as an MOU, between School Districts and Law Enforcement Agencies?

It is an agreement between school districts and law enforcement agencies about the payment, placement, and obligations of officers placed in schools. Some states now require an MOU be created when officers are placed in a school to clarify expectations, roles and responsibilities, and make public what the school community can expect.

A robust MOU helps clarify the complexity of this relationship. SFY believes an MOU should describe, at a minimum:

- the roles and responsibilities of police officers who are either deployed in schools, or who enter a school building when they are called in,
- how officers will interact with students and school staff regarding disciplinary matters, and
- when school staff may call on an SRO to respond to a situation.

This is a murky area; often both officers and school staff are unclear as to when officers should intervene in incidents involving students. And, if it's confusing for staff and officers, imagine how confusing it will be for parents and students. To reduce confusion, a clear and comprehensive MOU, with the roles clearly spelled out, that describes exactly when, how, and under what conditions an officer will become involved in student behaviors is necessary.

A thorough MOU will also include information about:

- how officers are selected.
- the type of training they should receive,
- how the officer will be evaluated
- whether they will be trained with school staff, and
- how parents and staff can file complaints or compliments, if necessary, about how an officer treated or interacted with a student in school, and how these complaints will be handled.

SFY also strongly recommends that MOUs contain information on these topics:

- information sharing and student privacy,
- how the school community will be introduced to the officer, and
- how and when students may be questioned and who must be notified.

In this document, we offer a checklist of questions that should be answered by every MOU. Doing so will help clarify roles, responsibilities, and lines of communication, thereby preventing problems later on, while putting on notice and clarifying to all members of the school community how law enforcement officers will be integrated into the educational environment. An MOU, especially if it is public and used as a guide, can prevent much of the confusion that too often characterizes the officer—student—school staff relationship, and contribute to more healthy and robust communication between all parties.
